



## PRIVACY POLICY

Echuca-Moama RSL and Citizens Club Limited ABN 40 003 684 624 trading as "Moama RSL" and our related entities appreciate that privacy is very important to people. Moama RSL has adopted this Privacy Policy as we recognise the right of our members and guests to keep their personal information private. This Privacy Policy covers Moama RSL's treatment of personally identifiable information that we collect or hold. Like many other organisations, Moama RSL must comply with the National Privacy Principles contained in the Privacy Act when dealing with personal information.

### The information we collect

Moama RSL will collect general information about you, such as your name, address, contact details and other Clubs you belong to when you apply for membership to Moama RSL. This information is required under the Corporations and/or Registered Clubs Acts. We may also collect this and other types of personal information, such as your membership number, during the course of dealing with you, for example when you wish to obtain goods or services from Moama RSL and when you participate in contests and promotions or return feedback forms. In the interests of security and safety, and the comfort of members and guests, Moama RSL also operates video cameras within the premises and may collect personal information in the course of investigating complaints or pursuing disciplinary proceedings.

Where practicable, the purpose for which we collect personal information will be made clear at the time of collection. If you do not provide us with certain information we may be unable to accept your application for membership or provide you with access to our services.

Users can generally visit Moama RSL's website without revealing who they are or other personal information. Moama RSL will not collect any personal information about visitors to the website except when they knowingly provide it.

### How we use your information

Moama RSL will use the personal information we collect for the purpose disclosed at the time of collection, or otherwise as set out in this Privacy Policy. We will not use your personal information for any other purpose without first seeking your consent, unless authorised or required by law. Generally we will only use and disclose your personal information as follows:

- (a) to establish and maintain your membership to Moama RSL and Moama RSL Advantage Card, including displaying in the club and in some cases disclosing your name and address (as required by law) and providing you with newsletters, quarterly magazines, annual reports and other information necessary to allow you to play an active role in Moama RSL, such as information about candidates standing for election to the board of Moama RSL;
- (b) to provide the products or services you have requested from Moama RSL;
- (c) to answer your inquiry;
- (d) to register you for events, promotions or competitions;
- (e) in accordance with the Constitution of Moama RSL;
- (f) to assist us to make Moama RSL's sites, services and products more valuable to our members and guests;
- (g) for direct marketing of products or services and to keep you informed of new developments we believe may be of interest to you. If we contact you in this way without obtaining your prior consent, we will provide you with the opportunity to decline any further marketing communications;



- (h) to third parties where we have retained those third parties to assist us to operate Moama RSL and provide the products or services you have requested, such as marketing consultants and promotions companies, catering and event coordinators, businesses operating from our premises, website hosts and IT consultants, electronic gaming organisations, and our professional advisers such as management consultants, lawyers and accountants ; and
- (i) to different parts of the Moama RSL Group to enable the development and marketing of other products and services and to improve our customer service in general.

## Access to your information

You can request access to the personal information that Moama RSL holds about you by contacting Moama RSL's Privacy Officer as set out below. We will provide you with access to your personal information unless we are legally authorised to refuse your request (we may charge a reasonable fee for providing access.)

If you wish to change personal information that is out of date or inaccurate at any time please contact us. After notice from you, we will take reasonable steps to correct any of your information which is inaccurate, incomplete or out of date. If you wish to have your personal information deleted please let us know and we will delete that information wherever practicable.

We may refuse your request to access, amend or delete your personal information in certain circumstances. If we do refuse your request, we will provide you with a reason for our decision and, in the case of amendment, we will note with your personal information that you have disputed its accuracy.

## Security

Moama RSL will take reasonable steps to keep secure any personal information which we hold and to keep this information accurate and up to date. Personal information is stored in a secure server or secure files.

The Internet is not a secure method of transmitting information. Accordingly, Moama RSL cannot accept responsibility for the security of information you send to or receive from us over the Internet or for any unauthorised access or use of that information.

## Changes to this Privacy Policy

Moama RSL may amend this Privacy Policy from time to time by posting the amended version in Moama RSL or on this website.
